## MINUTES

The W9PVR monthly meeting was held at the Galaxie Skate Center in Richland Center, on Monday, November 11, 2024.

The meeting was called to order at 7:00 p.m. by President, Mike Kaufman.

There were several speakers regarding event coordination, ICS public safety forms, etc. No possible way to get AUxCom done in our part of Wisconsin (Casey Marshall commented that this was similar to Tactical Dispatch). Dave Owens (N9TUU) received the Emergency Coordinator Leadership Award. Chris also mentioned that Steve Palmer, LaFarge Police Chief, is a licensed amateur radio operator now, and he is hoping to get an amateur radio for the squad car.

Chris Kanable spoke about the Skywarn Recognition Day in La Crosse on December 7<sup>th</sup> from 8 a.m. to 4 p.m. The location address is N2788 County Road FA in La Crosse. The Mississippi Valley group usually has their bus on display there.

Open Discussion:

There was discussion about the ZOOM sessions for our Club meeting. Mike Kaufman will continue to provide the access to ZOOM at no charge.

The topic of incorporating presentations into our Club meetings was further discussed from our previous month's meeting with specific topics of interest as follows: radios (selection--price, functionality), D-Star system and D-Star radios, Packet Radio, Software Defined Radio (SDR), cables, connectors and antennas. Mike Kaufman has a video (about 40 minutes) from a presenter about weather, which he plans to present in March. Mike also mentioned that he could talk about the D-Star system in January (may have to be in February).

Jeff Williams mentioned that the Knights of Columbus organization want to form a group to assist the Emergency Management team when/if needed in the future. Jeff will get more information about this as to 1) specifically what they plan to do, and 2) how to organize this group, etc.

It was noted that the D-Star system and camera are running fine on the Tower Hill site. Daniel Brown and Jake Barbieur will work on getting the All-Star Link operational.

There was a QSL card sent to the Club, which Ralph Hendrickson will respond to the sender, regarding a contact by one of the Cub Scouts during the Jamboree On The Air (JOTA) with the Club last year.

We discussed the Christmas Holiday Party in conjunction with the December monthly meeting (December 9<sup>th</sup>) at the Galaxie Skate Center hosted by Phil Wallace. The doors will be open starting at 5:00 p.m. for our social time; pizza will be served at 6:00 p.m. Soft drinks will also be available. The regular meeting will start at 7:00 p.m. Please contact the secretary if you plan to attend, so that we can get an approximate number of attendees for Phil's preparation of the food. At the Club meeting, there were approximately 10 persons planning to attend.
